
To put it more bluntly you'll be growing more closely into the likeness of Christ for which you and all of us are destined.

General Information

Introduction

What is the general lay training pathway?

Alongside Authorised Lay Ministry (ALM), we now offer the general lay training pathway for those wanting to access lay training and development more informally. The pathway involves a more simplified application process than ALM but will still require a supportive recommendation from an appropriate parish representative. Post training, we strongly encourage some form of locally recognised celebration or commissioning, with the ongoing support and care of the participant remaining under the oversight of the local parish. It will also be the responsibility of the local parish to ensure that the appropriate safeguarding training and DBS checks are in place for any resulting ministry roles or duties

What courses are on offer for 2024?

There are currently 8 courses available for application, all of which will run between April and July at a variety of venues around the diocese. For more information and details on each course please refer to the following outlines.

Please note that we do our best to make the training courses as accessible as possible to all participants. However, if there are not enough candidates to run selected venues then alternative arrangements may need to be made or courses may be cancelled.

Course Aims, Goals and Expectations

Course Aim

To empower, enable and equip lay people to become courageous whole life disciples capable of ministering effectively and collaboratively in our shared mission of growing, nurturing and serving our local parish churches and communities.

Course Goals

 \cdot To provide participants with a safe and unique learning environment where they can develop and grow alongside fellow Christians from a variety of church traditions and backgrounds.

• To empower participants to develop their calling and gifts and to deepen their ongoing journey of faith as whole-life disciples of Jesus in the everyday stuff of life, #MoreThanSunday.

 \cdot To enable participants to grasp our Great Commission to mission and the knowledge and skills required to work effectively, courageously and collaboratively in their own parishes and local contexts.

 \cdot To equip participants with the tools they will need to grow and thrive and the resources required to remain fruitful and sustainable.

Course Expectations

Attendance

To be eligible for a course completion certificate, all participants must maintain a minimum attendance rate of 75%. This is to ensure that a base level of training has been met and that all participants are equally equipped.

Leading Opening Prayers/Reflections

During the course we encourage participants to take turns in planning and leading a short time of opening prayers/reflections. Further guidance and support for this will be provided.

Learning Journal

Participants are encouraged to keep some form of reflective learning diary/ journal. This is intended to take no longer than 15-20 minutes after each session and is part of developing the skills of reflective practice. Further support and guidance on this will be provided.

Reading

There is no expectation for course participants to do lots of extra reading. However, for those wanting to delve a little deeper there will be suggested resources and recommended reading lists provided. Participants will also be given full access to the borrowing library at St Johns House.

Learning Task

As part of the course, participants may be given the opportunity to prepare and submit a short learning task set by the tutor. This could be a short book review, a presentation or a similarly related task. Guidance and support for this will be provided.

Parish Visitation(s)

As part of reflective practice and personal development we ask that all participants arrange at least one parish visitation during the course. This tends to work best if it is to a parish that is different from their own context in terms of tradition and practices. Guidance and support on this will be provided.

Ministry Training Courses

Children and Families

Learning Goals

 \cdot To explore and learn more about the social development of children and young people and its impact on our ministry and work with them.

 \cdot To explore and understand some of the key principles of relational children's and youth work so that participants can contextualise these to their local parishes, projects and communities.

 \cdot To make space for participants to dream and get excited about potential programmes of children's and youth work applicable to their context, and then be able to identify key resources that would enable them to develop and deliver these.

 \cdot To equip and train participants in specialist areas of children's and youth work, such as mental health, messy church, faith development and schools work.

 \cdot To ensure that all participants are up to date and understand current guidelines and best practice in youth and children's' work.

 \cdot To equip participants in rethinking their contextual approach to the 'departure' after confirmation and secured secondary school places.

Course Delivery and Venues

Continuing the success of EQUIP'23, we are going to deliver the core content of this course in person over an intensive weekend. This will be appropriate for both children and youth leaders, and will contain separate sessions that cover more specific training for the distinctive age ranges.

The aim is then to offer 3 additional in person gatherings that will create further space to learn together but also provide continued opportunities to meet in separate elective groups too. Our experience of last year's training was that this created lots of opportunities to share experiences, resources and best practice with each other.

Community Outreach & Social Action

This elective is delivered by our partners at Greater Together Manchester (GTM). GTM was founded as a joint venture between the Diocese of Manchester and Church Urban Fund and is often referred to as the social action vehicle for the Diocese. GTM's vision is to see people and communities all over the Diocese of Manchester flourish and enjoy life in all its fullness. We support churches to be a truly transforming Christian Presence in Every Community.

Learning Goals

 \cdot To give participants an understanding of the major challenges facing communities in the UK today, and how the church can work with other partners to respond appropriately.

 \cdot To enable participants to develop their understanding of community outreach and social action as mission, and why engaging in these activities is a vital part of the Christian Faith.

 \cdot To understand how engaging in community outreach and local social action can lead to church growth.

 \cdot To equip participants the confidence and skills to grasp opportunities for community outreach and social action in their own locality and context.

Course Delivery and Venues

Sessions will primarily be on Saturdays, with a focus on in-person learning. The teaching locations will be confirmed once we know where participants are based. Some travel may be required to visit community projects around the diocese.

The course is made up of sessions focusing on the major issues facing our local and regional communities and will explore the theology of social justice, the context of our communities, models of community work and the link between social action and church growth. Research and case studies will be used to look at how churches have already been responding to these issues, along with field trip visits and discussions to inspire participants and show them what is possible.

Prayer and Spirituality

Learning Goals

•To develop and grow participants' own prayer life so that prayer becomes a way of living and being in the everyday stuff of life.

•To teach and nurture a wider understanding of prayer through all its different styles, practices and traditions, including the practice of daily prayer journaling.

•To resource and equip participants so that they can confidently develop their own ministry in prayer and spirituality in collaboration with their clergy.

Learning Goals

 \cdot To explore and learn more about the social development of children and young people and its impact on our ministry and work with them.

 \cdot To explore and understand some of the key principles of relational children's and youth work so that participants can contextualise these to their local parishes, projects and communities.

 \cdot To make space for participants to dream and get excited about potential programmes of children's and youth work applicable to their context, and then be able to identify key resources that would enable them to develop and deliver these.

 \cdot To equip and train participants in specialist areas of children's and youth work, such as mental health, messy church, faith development and schools work.

 \cdot To ensure that all participants are up to date and understand current guidelines and best practice in youth and children's' work.

 \cdot To equip participants in rethinking their contextual approach to the 'departure' after confirmation and secured secondary school places.

Course Delivery and Venues

Continuing the success of EQUIP'23, we are going to deliver the core content of this course in person over an intensive weekend. This will be appropriate for both children and youth leaders, and will contain separate sessions that cover more specific training for the distinctive age ranges.

The aim is then to offer 3 additional in person gatherings that will create further space to learn together but also provide continued opportunities to meet in separate elective groups too. Our experience of last year's training was that this created lots of opportunities to share experiences, resources and best practice with each other.

The application closing date for general lay training applications is Sunday 17 March, 2024.

Frequently Asked Questions

Does the training involve any assignments, tests or exams?

There are no assignments, tests or exams on the courses. There may be a limited amount of prep work that is optional between sessions, but the ethos of the course is more focused on group discussions, reflective practice and real-life application. However, for those wanting to take things deeper there will always be suggestions for further reading, resources and ongoing development.

How much does the training cost?

There are no training costs as all course fees are met by the diocese. However, parishes are expected to support their candidates if help is required with basic costs such as travel expenses. Where finances are a barrier to participation, parishes are encouraged to contact the Local Ministry Officer for further advice and support.

Does the training have an age limit?

The training has no age limits but special consideration would need to be given to anyone applying under the age of 18 to ensure that they are appropriately supervised and have the full permission of their parent/guardian.

Can you still apply if your parish is in vacancy?

Yes, during vacancies/ interregnums the application reference required from the parish can be completed by the Churchwarden, Licensed Reader, Team Rector, Mission Community Leader, Area Dean or another suitable minister/ church leader.

What do I get at the end of my training?

In recognition that all lay training is something that should be encouraged and celebrated, participants will receive a course completion certificate signed by the Diocesan Head of Lay Training and Development. It is then up to the participant and the local parish to discern how best to utilise the training in terms of potential ministry roles and duties. Further support for this will be provided by the Local Ministry Officer.

How is general training different from Authorised Lay Ministry training?

Participants may find themselves training alongside Authorised Lay Ministers (ALMs) on the same course. ALM is a different lay training pathway that includes a more in-depth application process, extra training requirements and a recognised higher level of leadership and safeguarding responsibility. After training ALMs are authorised by the Bishop of Manchester to carry out a mutually agreed ministry role back within their local parish context. An ALM's authorisation lasts for 3 years after which time it can be reviewed. For more details about ALM please see the diocesan website:
