
ACAT FREE MEMBERSHIP FOR CHURCHES IN OUR DIOCESE

It is an excellent tool and all potential users are encouraged to register and use it on a regular basis to gain the maximum benefit.



HOW TO USE 'THE CHURCH ORGANISER' AND 'MY FUND ACCOUNTING ONLINE'

The Church Organiser is the next stage in the life of The Life Events Diary, giving you even more tools to help streamline and improve your administration.

Building on three great years of The Life Events Diary, you can now manage any rooms which you hire out to the community, and provide tickets for events in the church life, whether they're concerts, conferences or holiday clubs. The Church Organiser provides some additional tools for your tool kit and is absolutely free of charge for all Church of England churches.

My Fund Accounting Online (The Church of England's recommended platform for church accounts) is an accounting package written especially for churches. It has been designed by people who have been church treasurers who fully understand the complexities of fund accounting and want to make life simpler for treasurers.

Built on nearly 40 years of writing software for churches My Fund Accounting Online has modern, easy to use screens and a host of features designed to make your life easier. It automates many processes by integrating with different systems to minimise the manual input you need to complete to produce your accounts. A wide range of compliant accounting and fund reports are available at the click of a button as is the Return of Parish finance.

My Fund Accounting Online will connect up with The Church Organiser so your church will be able to generate invoices for payment from the software including a hyperlink to receive the payment directly into your church's bank account. It will also handle ticket sales in a similar manner.



GASDS CLAIMING AND MAINTAINING THE REQUIRED HMRC AUDIT TRAILS

During the last few months the Gift Aid Lite team has provided advice and guidance to a number of churches regarding the Gift Aid Small Donations Scheme (GASDS).

In some cases, this has unfortunately resulted in the churches being instructed not to claim on historic cash based donations, and with future donations only being claimable once their cash counting and audit processes have been improved to meet HMRC requirements.

EXPECTED COUNTING AND BANKING PROCESSES

To ensure your cash donations in numbered envelopes and the open plate are GASDS claimable, please make sure you are completing the following steps:

- 1. Recording the total amount of cash donations collected and the date of the service.
- 2. Two non-related individuals are counting the monies.
- 3. Each envelope should have the following information written on it: the counter's initials, the donation amount, and cheque, if not a cash donation.
- 4. A full cash breakdown/vestry sheet should be used for each donation date (a template copy can be requested via email or downloaded from Parish Buying).
- 5. Some churches have an envelope register on the reverse of the vestry sheets, so the donation amounts (stating if it was a cheque) are recorded against each number. This means the Treasurer/ Gift Aid Secretary does not need the original envelopes to process a HMRC claim.
- 6. This cash record maintains a clearly identifiable audit trail to the bank paying in slip.
- 7. If the monies are not banked every week, or the bank/building society/Post Office does not accept part bags of coins, please use a carried forward and brought forward system to maintain this audit trail.
- 8. Make sure you follow HMRC's GASDS guidance:

"It is important that small cash donations are banked if your charity wants to claim a GASDS top-up. If your charity uses small cash donations to pay for expenses without banking the donations first, you will not be able to claim a top -up (GASDS) payment."

BANKING CASH INTACT

Please do not use your cash collections to reimburse expenses, or use them for petty cash, prior to paying in the monies at your bank, building society or Post Office. HMRC requires a clear audit trail between your cash records and your paying in slips to claim GASDS legally.

DEVICE DONATIONS

Donations of £30 or less from a giving device (not online) are eligible for GASDS, and please ensure these donations are paid directly into the church's bank account.

GASDS RULES AND ELIGIBILITY

Cash and device donations of £30 or less donations can be claimed via GASDS. Many churches rely heavily on their GASDS claims of up to £8,000 of donations per tax year, resulting in a GASDS claim of up to £2,000. If your church is part of a multi-church parish or benefice, with a single HMRC Gift Aid reference, and you are not claiming GASDS for each church, please get in touch.

TOGETHER FOR GOOD: THE £5,000 FUNDING INITIATIVE

IS YOUR CHURCH STILL USING EASYFUNDRAISING'S ONLINE DONATIONS SERVICE?

Your church needs to take action if it is still using easyfundraising's online donations service to provide a 'donate now' button on your website or A Church Near You page. This is because the service is being discontinued from Thursday 24th October onwards.

Your church's easyfundraising administrator will have

already received an email containing this information.

NATIONAL LOTTERY HERITAGE FUND ANNOUNCES £100M OF FUNDING FOR PLACES OF WORSHIP

The National Lottery Heritage Fund (NLHF) has announced it anticipates providing funding of £85 million for places of worship over the next three years. Places of worship are strongly encouraged to apply for this funding via NLHF's existing grant programmes, which have been simplified, and more information on these changes can be found here.

NLHF GRANT FUNDING

NLHF grants are provided from £10,000 up to £10m. If you are interested in applying, advice is provided to take your church through the first steps:

- 1. Explore the good practice guidance
- 2. Get inspired by some places of worship <u>case</u> <u>studies</u>
- 3. Read the application guidance
- 4. Find out what to do next when you are ready submit a project enquiry (for funding between £10,000 to £250,000) or expression of interest (for funding from £250,000 to £10m) to get advice from a local NLHF team

CHURCH OF ENGLAND FUNDING

NLHF has also provided £4.68m for the Church of England's Cathedral and Church Buildings
Department's conservation grants over the next five years from January 2025. This funding will help churches to preserve historical features including: stained glass windows, paintings, clocks, bells, organs, and monuments. Additionally, it will be used by the Church of England to offer training and projects to enhance advice and guidance provided to churches. For more information click here.

STRATEGIC INITIATIVES

A specific £15m fund has been created for projects with a strategic impact over the next three years. Currently, there are four Strategic Initiative themes and more information can be found here.

One of the themes is called Heritage in Need: Places of Worship, and applications will be considered for projects that have the potential to make an impact at a regional or national sector level, and will:

- Proactively tackle long-standing heritage issues at a large scale
- Enable a coordinated cross-territory approach that will strengthen delivery
- Address gaps where proposals are not coming through their NLHF grants programme
- Accelerate new ideas and interventions where a deliberate approach is needed

Therefore, individual places of worship are not eligible for funding through this Strategic Initiative, nor single site applications for capital works.

LISTED PLACES OF WORSHIP (LPW) SCHEME

The <u>Listed Places of Worship (LPW) scheme</u> was introduced by Gordon Brown, former Chancellor of Exchequer, in 2000. The LPW Scheme provides a grant equivalent to the cost of VAT on repair and maintenance work and associated professional fees on listed churches.

The funding is provided by the Department for Culture, Media and Sport. This is presently due to expire on 31st March 2025.

A national campaign is running to ensure this funding is renewed. Churches are being encouraged to write to their MP to explain what the LPW scheme means to them. You can find your MP's email address here.

BISHOP'S ORDINATION FUND COLLECTIONS AT CLERGY LICENSING, CONFIRMATION, AND VISITATION

New arrangements have been introduced for collections at clergy licensing, confirmation, and visitation services at our churches.

All in-person donations (e.g. one-off envelopes and open plate) are to be kept by the hosting church and claimed as Gift Aid or GASDS by them. This means the church can use their own Gift Aid envelopes, so they don't need to be requested from the diocese any more.

The diocese would be grateful if churches could continue to encourage people to donate to the Bishop's Ordination Fund. Information on how to do this can be found at www.manchester.anglican.org/ support-for-parishes/giving-and-fundraising/donate/. Donations can be made using an online giving page and cheques. A printable Gift Aid declaration is also provided.

Please ensure information explaining how to make an online donation to support the Bishop's Ordination Fund is included in the printed order of service, and shared verbally with the attendees during it.

The instructions shown in the template orders of service for the licensing of new clergy are available to download here www.manchester.anglican.org/supportfor-parishes/parish-administration/licensing-newclergy/. Each one includes a short paragraph and a QR code that can be easily copied and pasted for confirmation and visitation services, and this is provided on the final page of each of the downloads. This wording can be easily amended, if needed.
