The church is run on a day to day basis by a number of committed lay individuals who believe in the importance of sustaining the Anglican tradition within this area.

As a parish we are looking for someone who will focus his/her attention on this parish above all else to bring about growth within the parish. The right person will have all of the gifts and skills set out in section 13 but above all will be a person of faith, hope and optimism.

4 LOCAL COMMUNITY

Within the local community there is a large number of minorities chiefly of African and Eastern European origin. (38%)

The parish ranks as one of the most deprived in the country: 117 out of 12239 (CUF)

The housing stock is comprised of privately owned for rental, the latter meaning that population is transient in nature.

The age profile of the area is getting younger both in church congregation and the wider community.

The population of the area is rising as new housing continues to be built.

The parish is on the boundary with the new North Manchester Business Park and North City Shopping Centre with its Library and leisure centre with swimming pool and fitness provision. Nearby are large green spaces (eg Boggart Hole Clough Park), Youth facility (Factory Zone), riding school and Manchester Dogs Home. A six form college is near the Shopping Centre and secondary Academy are within easy reach.

Close by is Moston Lane which houses a variety of local businesses, predominantly of African and Eastern European ethnicity.

North Manchester General Hospital is approximately 3 miles away, doctors and dental surgeries are nearby.

The area is well-served by bus routes into the city centre and the tram service is just over a mile away from the church.

 In the past the Church had strong links with Lily Lane Primary School and there is a willingness of Moston Lane School to develop an active link.

6 WORSHIP AND WORSHIPPERS

What is the present pattern of Sunday and weekday worship? Which books and rites are in use, and what is the normal vesture for ministers? In the congregation(s), what is the mix of age, gender, and social groups? How many worshippers live outside the parish boundary? In the spectrum of church tradition how would you describe the worship – "evangelical", "central", "catholic", or some variation, or in other terms? What else should be recorded?

Worship is Eucharistic, vestments are worn and the sacrament is reserved. On Sundays there is either a sung or said Eucharist (via TV screens). Major festivals are observed as are Holy Week and the Easter Triduum. Common Worship and Common Worship : Times and Seasons are used.

Lay people assist with the chalice. Vestments are worn by ministers. The tradition is broadly "catholic" but modern and liberal rather than extreme. This tradition is unique within the immediate surrounding area, the adjoining parishes being Evangelical and Forward in Faith.

The age profile of the congregation is mixed. The social dynamic of the congregation is varied. A significant number of the members of the congregation are from majority ethnic groups, primarily African. The mix is approximately 50/50 split female to male. The majority of the congregation are of working age.

7 CHURCH-BASED ORGANIZATIONS AND GROUPS

There is a fortnightly Saturday morning "Pop In" which is run by members of the congregation. It encourages local people within the area to come along, walk through the doors and enjoy conversation, a coffee and a little company. There is a "good as new" for bargains and whilst a little money may be raised for church funds, the goal of this venture is for St. John's to continue to be seen as a place where all are welcome.

It is proposed that St John's be linked with St Matthew with St Mary Crumpsall to create a new team of parishes working in collaboration.

Presently, we are part of a larger group comprising of 6 parishes, originally all under the same Priest-in-Charge. However, with a further parish interregnum within the mission unit and an existing incumbency (two parishes) re-organisation was desirable.

There are Black Evangelical/Pentecostal churches in the parish.

A black Pentecostal-type congregation uses our worship area for worship each Sunday..

The parish has no curate, no Readers, and one ordained minister licensed to officiate (Revd Canon Roy Chow) and there is no accredited Ordained Local Minister.

The congregation is faithful but is slow in 'coming forward'. The congregation is largely African migrant, attracted to the area because of low rented terraced housing. With appropriate encouragement they should be the future for St John's Church as the remaining 'white' members are elderly.

Our plans for growth are influenced by these factors:

Our worshipping community needs to become more aware of our needs and how those needs can be changed into opportunities.

Our church building which is full of light and beauty, fully modernised, converted for community use and well maintained is a great resource as we reach out to the wider community. To quote: "we are a worship centre, a point of stability" (see article and photos on the re-ordering of the church in "Opening our Doors" by Akker and Passmore published by the Children's Society 1996 pp 131 - 6)

We seek to develop and sustain an Anglican presence within the wider community and the church plant is a superb base to use. There is full disabled access.

Our worshipping community is loving, warm, diverse, open to newcomers and has non-judgmental attitudes.

Our need to address lay and ordained leadership issues have already been stated. We wish to see an expansion and development in our networking with other agencies and community groups.

There is a need for a stewardship campaign but this is something which has been neglected.

The parish is fully committed to paying the Parish share which continues to be paid in full year-on-year despite increasing demands on our income. In it's history the Parish Share has been paid in full.

The parish is committed to charitable giving albeit financial difficulties in recent years have not always enabled the parish to give 10% of its income to charity. Nonetheless the parish remains committed to charitable giving.

13 THE NEXT PARISH PRIEST

In the light of and with reference to all of the above, and in particular your mission priorities (see 10), what kind of priest are you looking for? What are the key priorities that you would like them to address? What are the gifts and skills you would hope to they will bring?

The next parish priest must have some experience of building up a congregation.

The next parish priest will have the gifts and skills to work with us for growth. It is for us, a matter of his/her giftedness, rather than the importance of specific gender, age family situation etc. We fully support the ministry of women and welcome a woman as our parish priest. We accept wholeheartedly that this post will be a shared post but we are confident that the right person is out there.

The gifts and skills that the PCC hope for in this person can be summarised as follows:-

- A person to whom prayer and worship are central and who can inspire us to learn and pray more.
- Someone who can communicate in language that the people of Moston can readily understand and who has warmth of personality to which people can easily relate regardless of sex, class or ethnicity.
- A person who has ideas/strategies for young people and children in the worshipping congregation.
- A person who is able to connect with local schools and families in the parish.
- A person who has experience of community use of church buildings.
- A strong leader to take us forward in our mission
- Someone who is pastorally minded and who can encourage the existing mutual care within the congregation.
- A good team worker who can work with and support the PCC to promote mission and witness.
- Someone caring and approachable
- Above all a person of faith, hope and optimism.


