

b. Approximate key dates for the building

St Paul's Church was built in 1856 and consecrated in that year by the first Bishop of Manchester. Designed by Edwin Hugh Shellard in the Gothic style, St Paul's is a delightful building of excellent proportions. During its first hundred years, in a district which experienced grinding poverty, it suffered the ill effects of

inadequate funding for maintenance and the consequence of dire atmospheric pollution. In 1968 Stephen Dykes Bower, surveyor to Westminster Abbey, came to Salford and put in hand an extensive programme of repair and adornment. Visitors today come from far and wide to see a church restored to the beauty of holiness. The pipe organ is the work of Samuel Green and dates back to 1787, a magnificent baroque instrument, much spoken of and written about. Of great visual appeal is the fully decorated ceiling which never fails to lift up hearts and minds. Worth seeing are fine examples of craftsmanship in needlework, wood work, glazing and metal work. The Altar ornaments are the work of an early 20th century architect of note, W.D. Caroe. Parishioners care for St Paul's church with great devotion and in that work for God is our prayer. The church, the parish rooms, the garden wall and gates were listed as Grade II in 2003.

The subject was considered in detail pre 1994 by the PCC and Resolutions were passed. Subsequently the House of Bishops Declaration was considered and passed also in June 2017.

This was reaffirmed at a recent PCC meeting.

4. LOCAL COMMUNITY

What is the social character of the area?

The social character is mixed. It is made up of local residents who have lived here long term, a lot of housing was rebuilt in the 1960s. There are also new developments around the parish, which will increase the population. We also have several high-rise flats locally too around the church. Also, we have a connection with Lombardy Court, which has a mixture of elderly and disabled residents who live in a sheltered style accommodation. Plus, there will be a new Community Hub being built in due course just behind Lombardy Court. We have a large student population also as the parish includes part of the University of Salford and several students worship at St Paul's. There are social challenges within our local area like most places and we do have a high proportion of people locally who rely on the church for social need such as food and help with other practical matters in life such as furniture for housing.

What would you say are the main issues facing your community?

Cost of living crisis, lack of employment, addiction (alcohol, drugs), homelessness, high deprivation and a high level of refugees being housed locally.

What kind of houses make up the bulk of the parish?

The bulk of housing type is largely high rise flats followed by houses and there are plans to redevelop large areas of land to build 100's of new homes within the parish boundary.

What engagement with the local community does the church already have?

The church is a hub for the local community. We provide food parcels on a daily basis, advice and guidance to those who are homeless (up until covid we ran a homeless shelter based at the church). We also help people find furniture to furnish homes particularly those who have nothing.

We also work in partnership with Loaves and Fishes (a charity based project for self help and development, next door to St Paul's) as well as co-operation with other local churches in providing much needed support for local people.

We also are a base for a local charity 'Feed my City' which is an interfaith group that is run by the local Sikh Community who come along each week and provide hot meals for those in need.

We also work with Manchester Grammar School who bring students across regularly to help with the daily tasks at St Paul's and at Christmas provide much needed gifts for those in need who otherwise wouldn't have anything. They also perform an annual Christmas Concert each year at Lombardy Court.

What significant institutions such as factories, shops, offices, and hospitals are there?

There is Salford Shopping City 'the precinct' in the centre of our parish, a Job Centre, Doctors/Health Centre, a Dentist Practice as well as local supermarkets (quite a big Tesco's) as well as other local traders. We have quite an area that people travel to for shopping. Also, we have a Fit City Centre and an Art Theatre on the other side of the parish boundary as well.

No local industry as such.

13. THE NEXT PARISH PRIEST

In the light of and with reference to all of the above, and in particular your mission priorities (see Section 11), what are the key priorities that you would like the next parish priest to address? What are the gifts and skills you would hope they will bring?

We have recently entered into vacancy following the long and outstanding incumbency of Canon David Wyatt, Rector of this parish for 56 years. We have seen nothing but selfless devotion to the people of God in this place.

We hope that the next priest whilst we acknowledge cannot be the same as Canon Wyatt, will display a similar commitment (though aware 56 years might be a big ask) to us and the people of Salford. We would like to see that in our priest we have a shepherd, a servant, a steward, a watchman, a sentinel who will lead us, guide us, correct us and minister to us.

We would hope that he will be faithful in public worship and private prayer, preach and teach and celebrate the sacraments and admonish us when needed.

It is desirable that he 'knows the smell of the sheep' as Pope Francis tells all priests and that he will delight in getting to know us.

We would like to see strong links forged with the local church school and for these to be built upon and strengthened.

We are aware that things can never be the same again here at St Paul's but we are people of faith, a pilgrim people desiring of seeking God's will in our lives and we would like a priest that would show us Jesus.

We would like him to be able to be an affective communicator in order to reach out to local people in different ways, by making new connections within the parish in his outreach work. While also, having that personal touch to help rekindle old relationships once more and create new ones too.

In all it is hoped that the next priest will hold dear to the faith and traditions to be found at St Paul's, to bring us in line with current practice of how parishes are run these days and work closely with other Society Parishes as well as within the deanery to enable the Kingdom of God to flourish.

There is a legacy to build on here but we are not always looking back to the past but forward in faith into the future, trusting in God.
